COMPLAINT IN MANDAMUS TO REQUIRE OPEN MEETINGS

AND NOW COMES, PETITIONERS DAVID TESSITOR AND GLENN A. WALSH requesting that this Honorable Court order that the Carnegie Library of the City of Pittsburgh Board of Trustees conduct its meetings openly with access provided for the public and news media, and in support avers as follows:

1. Plaintiff David Tessitor is an adult individual residing at 833 Western Avenue, in the City of Pittsburgh, Allegheny County, Pennsylvania and is a library user of the Carnegie Library of the City of Pittsburgh and has an active interest in libraries.

2. Plaintiff Glenn Walsh is an adult individual residing at 633 Royce Avenue, in the Borough of Mount Lebanon, Allegheny County, Pennsylvania, is a library user of the Carnegie Library of the City of Pittsburgh, is a former life trustee of the Andrew Carnegie Free Library, Carnegie, PA, and has an active interest in libraries.

3. Plaintiffs have repeatedly requested and been denied access to attend the meetings of the Carnegie Library of the City of Pittsburgh as members of the general public.

4. On December 11, 2009, Suzanne M. Thinnes, Communications Manager, Carnegie Library of Pittsburgh sent an email to David Tessitor at 11:14:21 am stating: "Meetings of the Library's Board of Trustees, including the one scheduled for December 14, are closed meetings.

5. The Carnegie Library of Pittsburgh is a public library and Trust, the sole purpose of which is acting as an agent of the City of Pittsburgh in the provision of public library services to city residents.

6. The Carnegie Library of Pittsburgh, Board of Trustees consists of 36 members, 10 of which are public officials serving ex officio or are appointed from among their body as the ex officio representatives, and serving in their official capacities as elected officials as members of the board of trustees are making decisions on the administration of the public library services provided to the City of Pittsburgh and Allegheny County.

7. Pittsburgh Ordinance Number 240, passed by the Select and Common Councils of the City of Pittsburgh on February 24, 1890, signed into law by Pittsburgh Mayor William McCallin on February 25, 1890, and entered into Ordinance Book 7 page 265 of 1889-1890, accepted an offer by Andrew Carnegie to build libraries for Pittsburgh and officially designated these libraries as the "Carnegie Free Libraries of the City of

Pittsburgh."

8. The Carnegie Library of Pittsburgh continues to provide the public library services acting as the agent for the City of Pittsburgh in buildings owned by the City and leased to the Library through an agreement and leases authorized by Ordinance number 2002-1141 and approved by Pittsburgh City Council on December 4, 2002.

9. The Carnegie Library of Pittsburgh is designated by the Pennsylvania Department of Education district library for the Pittsburgh District.

10. The Carnegie Library of Pittsburgh accepts state funding as the public library serving the City of Pittsburgh.

11. Title 22 of the Pennsylvania Code, Section 141.21, Subsection (2), Part (i), Subpart (C) states: "(C) The library shall be an integral part of general local government."

12. "Agencies" of municipal government are required to abide by all aspects of the Pennsylvania Right-to-Know Law [Act of June 21, 1957, P.L. 390, No. 212, 60 P.S. 66.1 et seq., as amended] and the Pennsylvania Sunshine Act [Act of July 3, 1986, P.L. 388, No. 84, 65 P.S. 271 et seq., as amended], as are all other parts of municipal government.

13. The Pennsylvania Deputy Secretary of Education for Libraries advises all public libraries in the Commonwealth that they should conduct the meetings of their board open to the public unless qualifying as an executive session.

WHEREFORE, Petitioners request that this Honorable Court order the Carnegie Library of Pittsburgh Board of Trustees to

conduct their board meetings open to the public and to comply in full with the Pennsylvania Sunshine Act and Open Records Law.
